

DURHAM MIDDLEFIELD INTERLOCAL AGREEMENT ADVISORY BOARD  
REGULAR MEETING MINUTES  
Thursday, January 15, 2015

**Call to Order:** The meeting was called to order at 7:06 PM by Chairman Dom DelVecchio at the Middlefield Community Center.

**Approval of Agenda:** *A motion was made by Ron Capozzi and seconded by Jim Gibbons to approve agenda as written. The motion passed all in favor with Mr. Czarnecki in abstention.*

**NEW BUSINESS**

**Public Comment:**

Durham resident, David Goduri, is interested in starting his own Durham/Middlefield Hauling business and discussed this with the Board.

- Would a Hauler be able to waive the sticker fee for residents if the hauler was also a resident?

*The board answered: No, the sticker fee stands for residents whether they hire a hauler or not as long as the resident utilizes the transfer station. The hauler would also be charged the standard MSW tip fee and DMIAAB hauling fee if the transfer station were utilized. The hauler could haul direct to MIRA if the hauler desired to do so.*

- Where is the waste hauled to once it's dumped at the site?

*The board answered: CRRA/MIRA determines where the site brings it's MSW. DMIAAB is currently hauling MSW to the Hartford facility.*

The board encouraged Mr. Goduri to do more research, visit the DMIAAB site and ask questions. The board wished Mr. Goduri well in his endeavor to start his own hauling business.
