Greg Hanks made a motion to accept proposal as presented.
Dick Spooner seconded and passed unanimously
2. LITES: *"Jim Ledford engaged Planetta electric to repair lighting in front of Firehouse. To be done ASAP by John at time and materials rate. Greg Hanks made motion to proceed and pay as presented. Seconded by Jim Ledford, passed unanimously."* DONE
 3. GARAGE BAY DOOR #3: *"Door was broken last week. Door was fixed by Connecticut Overhead Door and they will be servicing doors before next meeting. Required for ongoing emergency support."* Not done YET. Jim Ledford to follow up
 4. FRONT AND REAR FLOOR TILES: *"Front and rear foyer floors have been a concern and a requested item of attention since April 2013. Funds were budgeted and allocated in both the Capital Improvement and the Maintenance budget. The Fire department as requested that the following be done:*
 - a. *Both front and rear floors be replaced*
 - b. *In both foyers install the Fire department logo.*
 - i. *Fire Department will assume the responsibility of designing the logo in a manner that is both aesthetically pleasing, durable and installable.*
 - c. *Jim Ledford will receive a quote and forward to Dick McManus for implementation."*
 - d. *Jim Ledford has received two bids; One VERBAL from Meriden Floor and Tile, but did not include demolition and disposal. The Second WRITTEN proposal received from Dalene Hardwood Flooring of Southington and presented at this meeting. Dick Spooner made a motion to accept the proposal as provided, Greg Hanks seconded. Passed unanimously.*
 5. CEILING TILES: *"When? Jim will follow up with Dick McManus."* No response to date. To be addressed forthwith.
 6. LANDSCAPING: *"As the requested landscaping has not been done, (Budget item from early 2014), Jim Ledford will compile a design document and we request that it be implemented as early as possible, but no later than April 1st, 2016."* Jim Ledford presented drawing and quote as per above request. Jim to see if the requested plants are available at a lower price than currently understood. Results to be updated in November.
 7. Laura Francis has presented a proposal from JK Energy Solutions to replace existing lighting with LED type illumination. The proposal offers a 3.91 year payback. We propose that this payback term be included in any binding contract, and be enforceable.
